**Summaries data:** Abamectin: Abamectin is an acute oral toxin [LD<sub>50</sub> (oral) 8.7

mg/kg]. Ingestion of a single large dose of abamectin by humans (~ 100 mg/kg) was associated with coma, hypotension and respiratory failure. Clinical signs in repeated-dose laboratory animal studies included ataxia, tremor, mydriasis, emesis, pupil dilation and coma. High doses produced respiratory failure and deaths. The critical adverse effects in multigenerational studies were mortality and reduced weight gain in early lactation (NOAEL 0.12mg/kg/d). Glycerol formal: A solvent with known potential for teratogenic and embryotoxic effects. At repeated doses of 0.25mL/day and above glycerol formal induced elevated post implantation losses and reduced foetal weights in rats (oral and injected doses). Foetal malformations occurred at doses of 0.5 and 1 mL/kg/day.

**Data organisation :** Abamectin: Abamectin is a highly effective insecticide and acaricide

produced by the soil microbe *Streptomycetes avermitilis*. It acts by stimulating the release of gamma-aminobutyric acid, an inhibitory neurotransmitter, causing paralysis of the parasite. It is highly toxic to invertebrates in the aquatic, soil and terrestrial environments. Aquatic organisms: Abamectin is highly toxic to fish and extremely toxic to aquatic invertebrates [LC $_{50}$  Rainbow trout is 3.6 ppb (96hrs); LC $_{50}$  Daphnia magna 0.34 ppb (48hrs) ]. Persist: yes. Soil organisms: Dung beetle Terrestrial fate value 20-40. Terrestrial Fate Soil DT50 >30 days. Birds: Abamectin is practically non toxic to birds [LC $_{50}$  Bobwhite quail >2000 mg/kg]. There were no adverse effects on reproduction when mallard ducks were fed up to 12ppm for 18 weeks. It is toxic to mammals [LD $_{50}$  (oral) 8.7 mg/kg]. Abamectin is highly toxic to bees [LD $_{50}$  (oral) 0.0094 ug/bee; LD $_{50}$ 

(contact) 0.002 ug/bee].

<u>Selenium</u>: Selenium is highly toxic to fish [LC<sub>50</sub> Fathead minnow is 0.69 mg/L(96hrs)], crustacean [LC<sub>50</sub> Rainbow trout 3.6 ppb (96hrs)], crustacea [LC<sub>50</sub> Grammarus pseudolimnaeus 0.083 mg/L (48hrs)] and algae [EC<sub>50</sub> Green algae 0.2 m/L (96hrs)]. Selenium is bioaccumulative and persists. Toxic to soil organisms. Toxic to terrestrial invertebrates based on an acute oral LD<sub>50</sub>(rats) of 25

mg/kg.
